We, the undersigned, acknowledge and agree that:

- 4** we hereby unconditionally and irrevocably provide a full and final release and discharge to each Y2i Released Person from, any and all claims, demands, causes of action and liabilities of any kind, whether present or future, actual or contingent arising from, related to or otherwise incidental to the Participant’s participation in the Israel Program which is being provided and operated by BJE, or any employees, agents, volunteers and contractors thereof;
- 5** Y2i or its agents has the right to take or use photographs and videos of the Participant and to use these in any and all media worldwide including online, now or hereafter known, and for any purpose in connection with the Y2i program, its objectives or those of the NSW Jewish community. I hereby release to Y2i all rights to exhibit this work in print and electronic form publicly or privately and to market copies. I waive any rights, claims or interest I may have to control the use of the Participant’s identity or likeness in the photographs and agree that any uses described herein will be made without compensation;
- 6** we voluntarily entered into this release and have read and understood all of its terms and we agree to be bound by all such terms before signing; and this release will be binding on us and our executors, administrators, heirs, next of kin, successors and assigns.
