We, the undersigned, acknowledge and agree that:

- 1** we consent to the personal information of the Participant (including, the name and contact details of the Participant and any financial or other information provided in relation to the Participant or parents and/or guardian of the Participant) (the Personal Information) being shared with Y2i Operations Limited or the Y2i Released Persons, for the purpose of recommending funding/subsidy/financial assistance support for the Program and for marketing and promotional purposes, communal research or purposes in support of communal engagement initiatives;

- 5** Y2i or its agents has the right to take or use photographs and videos of the Participant and to use these in any and all media worldwide including online, now or hereafter known, and for any purpose in connection with the Y2i program, its objectives or those of the NSW Jewish community. I hereby release to Y2i all rights to exhibit this work in print and electronic form publicly or privately and to market copies. I waive any rights, claims or interest I may have to control the use of the Participant’s identity or likeness in the photographs and agree that any uses described herein will be made without compensation;
- 6** we voluntarily entered into this release and have read and understood all of its terms and we agree to be bound by all such terms before signing; and this release will be binding on us and our executors, administrators, heirs, next of kin, successors and assigns.
